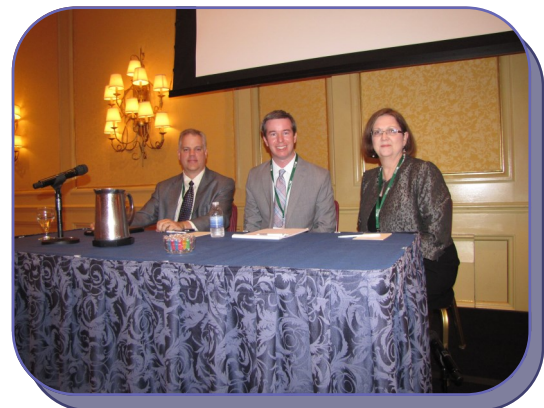

HIMSS Louisiana Chapter Scholarship in Health Informatics

The HIMSS Louisiana Chapter (LAHIMSS) is delighted to announce its inaugural offering of scholarships for the upcoming 2014-2015 academic year!

LAHIMSS has set an objective of fostering development of the next generation of leaders in the field of Health Informatics (Health Information or Management Systems) by providing financial assistance to well-qualified individuals who have been admitted to or will continue in a qualifying academic degree program as a student.

Two awardees will receive cash awards in the amount of \$1,000.00 each. The awards may be used at the discretion of the awardees to defray expenses associated with their formal education. Payments will be made to the awardees directly, in two equal installments of \$500 each – in August 2014 and in January 2015, upon the awardees' submission of evidence of initial and continuing enrollment. These merit-based scholarships will be effective for one academic year only, and are not renewable.

While the exact program and degree being pursued are not critical factors, preference will be given to students in academic programs in health informatics and information management, health-industry-focused computer science and information systems, and healthcare administration. Applications from students pursuing advanced degrees in professional school programs in medicine, nursing, pharmacy, and other clinical specialties will also be considered insofar as a significant component of their program is dedicated to Health Informatics.

Applicants must be an active Regular Members or Student Members of HIMSS and affiliated with Louisiana Chapter and, if awarded the scholarship, must remain active during the term of the award. Recipients will become official student liaison members of the LAHIMSS Board.
